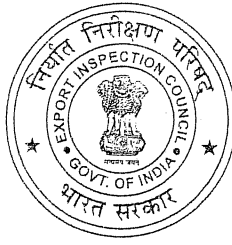
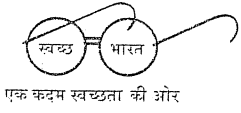

ORDER

Subject: Appeal made by Dr. Neeraj P. Awasthi, Uttar Pradesh under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Dr. Neeraj P. Awasthi, Uttar Pradesh, vide online application registration No. EICOI/A/E/25/00019 dated 29.05.2025, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against the reply submitted by CPIO, EIC vide online reply dated 28.05.2025 in response to online RTI application registration No. EICOI/R/E/25/00029 dated 30.04.2025. Dr. Neeraj P. Awasthi, vide RTI application dated 30.04.2025, had sought the information regarding payment of gratuity & other entitled benefits to the applicant. CPIO, EIC, vide online reply dated 28.05.2025, informed that the matter is under examination as per NPS Gratuity Rules.

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide online application dated 29.05.2025. The appellant in his appeal has stated that the CPIO has provided incomplete, misleading or false information and requested to provide the information.

Orders:

The Appellate authority has gone through all the relevant documents such as online RTI Application dated 30.04.2025 submitted by Dr. Neeraj P. Awasthi, the reply furnished by the CPIO, EIC vide online reply dated 28.05.2025 and the instant online appeal dated 29.05.2025.

On scrutiny of all the documents, particularly with reference to the RTI reply provided by the CPIO, EIC, the Appellate Authority finds no infirmity in the online reply dated 28.05.2025 of the CPIO, EIC. Hence, the appeal of Dr. Neeraj P. Awasthi hereby stands disposed of, without any further directions to CPIO, EIC. Further, it is appropriate to add that it is not open for an information seeker/appellant to enlarge the scope of his RTI application at appeal stage.

In case the appellant intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, the appellant may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
