#### **ORDER**

Subject: Appeal made by Shri Sai Muni Meduru, Andhra Pradesh under Section 19(1) of the Right to Information Act, 2005 – reg.

#### Facts of the Case:

Shri Sai Muni Meduru, Andhra Pradesh, vide online application registration No. EICOI/A/E/25/00023 dated 04.06.2025, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against the reply submitted by CPIO, EIC vide online reply dated 03.06.2025 in response to online RTI application registration No. EICOI/R/E/25/00033 dated 09.05.2025. Shri Sai Muni Meduru, vide RTI application dated 09.05.2025, had sought the information regarding copy of movement register, attendance register, leave details, on duty details and deputation duty details of Shri Nitin Y. Meshram, Deputy Director (Tech.) & Controlled Officer of Greivance No. DOPAT/E/2025/0003080, during the period from 17.03.2025 till the disposal of his RTI application. CPIO, EIC, vide online reply dated 03.06.2025, informed that the information cannot be shared as per 8(1)(j) of RTI Act 2005.

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide online application dated 04.06.2025. The appellant in his appeal has stated that the CPIO, EIC has provided false and misleading information and requested to provide appropriate order to the CPIO, EIC to provide the information as per his RTI application.

#### **Orders:**

The Appellate Authority has gone through all relevant documents of the online RTI Application dated 09.05.2025 submitted by Shri Sai Muni Meduru, the reply furnished by the CPIO, EIC vide online reply dated 03.06.2025 and the instant online appeal dated 04.06.2025.

It has been observed from the background of the instant RTI Application EICOI/R/E/25/00033 dated 09.05.2025 that the information sought by the RTI Applicant is based on the disposal of his CPGRAM grievance No. DOPAT/E/2025/0003080 by Shri Nitin Y. Meshram, DD (T), EIC, New Delhi. Accordingly, the RTI applicant has sought information about Movement Register copy, copies of Attendance Register, Leave applications, Duty details and Deputation duty details in respect of Shri Nitin Y. Meshram, DD (T), EIC, New Delhi.

The information as sought in the above mentioned RTI Application appear to be irrelevant, frivolous and meaningless as it seeks information about one particular officer who has duly disposed off his public grievance in exercise of his public duty. The tone and tenor of the information sought in the RTI Application about one particular officer of EIC, do indicate that the appellant, who used to serve as an outsourced manpower through a 3<sup>rd</sup> party vendor in EIA-Chennai, Sub Office-Nellore and had invited some adverse action during the course of past

engagement, is bent on using the RTI Act as a tool of vendetta against the Officer with an intention to pressurize, browbeat or harass the public authority. There appears to be no relationship of the information sought with any Public Authority or interest which indicates that RTI Act is being misused to intimidate and blackmail the authorities of this office and to settle his personal grievances and disgruntlement. There is no provision in the RTI Act for redressal of grievances in the garb of seeking information. It is substantiated by the fact that he has so far filed 64 number of RTI Applications and 50 number of RTI Appeals during the period from 05.04.2025 to 29.06.2025. In view of the above, It is evident that the purpose of obtaining information by the Appellant in this Appeal is with an intention to misuse the spirit of the RTI Act and to threaten this institution and it is for this reason that the RTI Appeal deserves to be dismissed.

Therefore, the Appellate Authority finds no infirmity in the online reply dated 03.06.2025 of the CPIO, EIC and as such, the appeal of Shri Sai Muni Meduru hereby stands disposed of, without any further directions to CPIO, EIC.

In case the appellant intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, the appellant may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
