ORDER

Subject: Appeal made by Shri Sai Muni Meduru, Andhra Pradesh under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Sai Muni Meduru, Andhra Pradesh, vide application dated 19.05.2025, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against the reply submitted by ACPIO, EIA-Chennai vide reply dated 08.05.2025 in response to RTI application dated 16.04.2025. Shri Sai Muni Meduru, vide RTI application dated 16.04.2025, had sought the information regarding total number of committees has formed to investigate the matter of integrity of sampling and sampling allotment process on contract employees as well as regular employees, from the date of joining to disposing the RTI application of the applicant. ACPIO, EIA-Chennai, vide reply dated 08.05.2025, had informed that the information cannot be disclosed as per rule 8(1)(j) of the Act.

In response to the reply of ACPIO, EIA-Chennai, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 19.05.2025. The appellant in his appeal has stated that the ACPIO, EIA-Chennai has provided false & misleading information under RTI Act, 2005 and requested to provide appropriate orders to the ACPIO, EIA-Chennai to provide the information as per his RTI application.

Orders:

The Appellate authority has gone through all the relevant documents such as RTI Application dated 16.04.2025 submitted by Shri Sai Muni Meduru, the reply furnished by the ACPIO, EIA-Chennai vide reply dated 08.05.2025 and the instant appeal dated 19.05.2025.

The RTI appellant, who used to serve as an outsourced manpower through a 3rd party vendor in EIA-Chennai, Sub Office – Nellore, in his RTI application has stated that "Mr. Jayapalan Gopalakrishnan, The Deputy Director (I/C), Export Inspection Agency – Chennai (H.O.), Chennai, has sent email to committee on 10.12.2024 for investigating the matter of Integrity of Sampling and Sampling Allotment Process". This statement of the appellant indicates that he is in the know of internal office communication exchanges taken place in the EIA-Chennai, Sub Office – Nellore. His attempt to seek information through multiple & repetitive RTI applications & appeals (he has so far submitted 61 RTI applications & 44 appeals after his services were terminated by the 3rd party vendor) shows his vengeance against his ex-workplace & authorities therein. The information being sought by him based on inside knowledge of his ex-workplace amounts to misuse of the RTI Act, 2005.

Further, disclosure of the information about, the details of name, designation, travel expenses, etc. of the committee members has no relationship to any public activity and public interest and

the appellant has not been able to show or explain any nexus between the personal information sought and public interest involved. Thus, in absence of even a remote connection with any larger public interest, disclosure of information would be exempted as the same would cause unwanted invasion of the privacy of the committee members under section 8(1)(j) of the RTI Act, 2005. The appellant has failed to establish that the information sought for, is for any public interest.

On scrutiny of all the documents, particularly with reference to the RTI reply provided by the ACPIO, EIA-Chennai, the Appellate Authority finds no infirmity in the reply dated 08.05.2025 of the ACPIO, EIA-Chennai. Hence, the appeal of Shri Sai Muni Meduru hereby stands disposed of, without any further directions to ACPIO, EIA-Chennai.
