## ORDER

**Subject: Appeal made by Shri P. Ponmurugesapandian, Madurai under Section 19(1) of the Right to Information Act, 2005.**

### **Facts of the Case:**

Shri P. Ponmurugesapandian, Madurai vide his application dated 03<sup>rd</sup> February, 2018 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application request dated 27<sup>th</sup> December, 2017, filed in EIA-Chennai.

Vide his RTI application dated 27<sup>th</sup> December, 2017, Shri P. Ponmurugesapandian, Madurai had sought the information regarding details of certificates issued under SAPTA during the calendar year 2017 for export of Potassium Chlorate (ITCHS Code 28291920) to Nepal.

CPIO, EIA-Chennai vide reply dated 23<sup>rd</sup> January, 2018, informed that the data of SAPTA certificates issued product wise, HS Code wise, Country wise and quantity wise is not available.

Aggrieved by the reply of CPIO, EIA-Chennai, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his application dated 03<sup>rd</sup> February, 2018.

The applicant, in his appeal, has requested to provide the information.

CPIO, EIA-Chennai has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to applicant and they state that they have nothing to append.

### **Orders:**

I find no infirmity in the reply of CPIO, EIA-Chennai, therefore dispose the appeal without any further directions to CPIO, EIA-Chennai.

This disposes off the appeal of Shri P. Ponmurugesapandian.
