Subject: Appeal made by Shri. K. Manoharan under Section 19 (1) of the Right to Information Act 2005.

## Facts of the Case:

Shri. K. Manoharan vide his letter dated 22.12.2016 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 29.07.2016.

Vide his RTI application dated 29.07.2016; Shri. K. Manoharan had sought the information regarding return of EMD against tender for appointment of PR Consultant in 2005-06.

CPIO, EIC vide letter dated 09.08.2016 provided the information to applicant. Further, the applicant forwarded a letter dated 17.08.2016, which was replied by CPIO, EIC vide letter dated 15.09.2016.

Aggrieved by the reply of CPIO, EIC the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 22.12.2016.

The applicant, in his appeal, has requested to provide the reason for not getting the EMD and is asking that what action has been taken in this regard.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to applicant and they state that they have nothing to append.

It is observed that the appeal preferred in this RTI is time barred and appeal should be rejected on this ground itself. However, looking into the spirit of RTI Act, appeal of applicant is admitted.

I find no infirmity in the reply of CPIO, EIC and therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri. K. Manoharan.
