5.3 PROCEDURE FOR ISSUANCE OF HEALTH CERTIFICATE TO SINGAPORE

The Establishment/Exporter intending to obtain health certificate for export of Peanut and Peanut Product (PPP) to Singapore, shall be approved by EIC under Food Safety Management System Certification (FSMSC) as per the Scheme for Issuance of Health Certificate for Export of Peanut and Peanut products to European Union (EU) and Malaysia (Doc no. EIC/Health Certificate Scheme for Peanut and Peanut Products for export to EU/Malaysia/Singapore/July 2013/Issue1/A1) or as per Consignment Wise Inspection (CWI) where establishment/exporter is registered with APEDA (The authority issuing the Registration Cum Membership registration/RCMC for Peanut and Peanut products export oriented establishments) under Peanut and Peanut Products Scheme of APEDA.

Exporters intending to export of PPP consignment to Singapore shall provide the following documents for issuance of Health Certificate as per Annexure IV.

- i. Application for issuance of Health Certificate
- Copy of Invoice/Purchase order/Letter of Credit or any other document considered relevant, along with requisite fees as specified in EIC letter EIC/D(Q/C)/T-4 (Peanuts)/2015-16 dated 06-04-2016 shall be submitted to the nearest Export Inspection Agency or its sub-office, under whose jurisdiction the exporter / manufacturer/ processor is situated
- iii. Declaration of exporter/processor/manufacturer as per Annexure I of the Scheme for Peanut and Peanut Products.
- iv. Sampling and Analysis Report of EIC/APEDA's approved laboratory in respect of the consignment for specified parameter i.e Aflatoxin B1 and Total Aflatoxin (B1,B2, G1 and G2) not exceeding the maximum limit of 5 ppb (Schedule II).
- v. EIC Certificate of Approval (CoA) / Registration documents with APEDA (e.g. copy of RCMC issued by APEDA)
- vi. Certificate For Export (CFE) from EIC / Certificate of Exports (CoE) issued by APEDA
- vii. The processors/exporters should produce, process and pack PPP ensuring HACCP, Good Agricultural Practices (GAP), Good Hygiene Practices (GHP), Good Manufacturing Practices (GMP) as required for the product and copy of said certification(s) shall be submitted.
